[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/29/10 I was dispatched to ██████████ in Milton, FL for a DV complaint.

Upon arrival I spoke to Kyle Smith. Kyle told me he and his family had just returned from a trip to Disney World and that his son, Ryan Ferraro, was left at the residence to take care of the house and the animals that were left there. Kyle said he noticed that the doors to the master bedroom and to the other children's rooms were broken and before he left all the doors were locked and he gave specific instructions to Ryan that he was not to enter any of the rooms that he had secured. Kyle told me that when he questioned Ryan, Ryan admitted to masturbating on Kyle's bed and his sisters bed

and clothing. Kyle said Ryan also admitted to him that he threw one of the dogs off the front porch, which is on the second story of the house and that he had sex with Buster, a female Pomeranian and Angel, an American Eskimo. I asked Kyle if Ryan had any kind of mental issues and he said yes.

I then spoke to Ryan Hayes Ferraro. Ryan was read Miranda Warnings and agreed to speak to me without a lawyer present. I asked Ryan what had happened in the residence while his parents were out of town. Ryan admitted to me that he had broke into the rooms that his father had locked, which consisted of his sisters and his parents room and masturbated on their bed and clothes. I asked Ryan what he had done to the dogs. Ryan said he had vaginally penetrated Buster, a female Pomeranian and vaginally penetrated Angel, an American Eskimo. Ryan said he also beat the dogs and threw one of the dogs off the front porch balcony, which is located on the second story of the residence. I asked Ryan if he had any other brothers and sisters that lived with him. Ryan said yes, his sister, [redacted] who is 12 years old and [redacted] who is 14 years old. I asked Ryan if he had any sexual contact with his sisters. Ryan said yes, that he had showed his penis to his younger sister and tried to have sex with her today when they returned home from Disney World.

I asked Kyle and Mishelle Smith if we could speak to their daughters in reference to a possible sexual battery involving Ryan and they both said yes.

Dep Bozard spoke to [redacted] and [redacted] told Dep Bozard that Ryan had asked her if she wanted some candy and showed her some reddish pills. [redacted] said she told him no. [redacted] said she was on the back porch and Ryan pushed her into the corner of the porch and dropped his pants. [redacted] went on to tell Dep Bozard that Ryan tried to get her to touch his penis and she kept telling him to get off of her. [redacted] said Ryan tried to get her clothes off but he wasn't able and that he was touching his penis and his pants were down. [redacted] said she stomped on his foot and he let her go and she ran inside and told her mom. [redacted] said that she was scared that Ryan was going to hurt her.

While finishing up my paperwork, Ryan asked to use the rest room. Sgt Dunne patted down Ryan for our safety and his and also checked the bathroom for any illegal narcotics and weapons. Sgt Dunne said he also checked the toilet and told Ryan not to flush the toilet after he got done using it.


I went into the bathroom after Ryan supposedly used the toilet to check if he had dropped anything in the toilet and I notified five pills in the toilet. I asked Ryan what were the pills he dropped in the toilet and Ryan denied placing the pills in the toilet. I informed Ryan that Sgt Dunne had checked the bathroom prior to him using it and did not notice any pills in the toilet. I had Ryan take the pills out of the toilet. The pills had lost their pink coated dye but I could still see a faint trace in the toilet but I could see the imprint of "OC" on one side of the pill and "20" imprinted on the other side of the pill. A check through Pill identifier confirmed that the pills were 20 mg of Oxycontin. I asked Ryan where he had gotten the pills and again he denied that the pills were his. I asked Kyle if he had any narcotics in the residence. Kyle said when he had an injury to his finger he was given some Oxycontin for his pain but did not know where the bottle was located due to him and his family just moving into the residence.

I then placed Ryan under arrest for lewd and lascivious behavior, possession of a controlled substance without a prescription, tampering with evidence and cruelty to animals.

Ryan was transported to the Santa Rosa County Jail. He was given no bond pending first appearance.

This incident occurred in Santa Rosa County, FL.


