[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

CAD INCIDENT DISPOSITION CODE: [6-0] [U] [3] []

On 6/22/10 in Escambia County Kenneth Williams did commit the offenses of Cruelty to Animals and Confinement of an Animal without sufficient food, water, and/or exercise as described, to wit:

On 6/22/10 I was dispatched to 10914 Bridge Creek Dr in reference to an animal incident. An anonymous caller had advised Dispatch that at this address there were 2 possibly 3 deceased dogs in the garage and maybe 2 or 3 live ones in the house. Dep. Dejoie #188 and I arrived on scene. As we exited our vehicles and began to approach the house we smelled a strong odor that seemed to be emanating from the house. As we got closer, Dep. Dejoie noticed that there was a window AC unit running. Once he got near this, the strong foul odor was even more evident. We knocked on the front door several times in an attempt to contact a resident, but was unsuccessful. Dep. Dejoie and I then walked around to the side garage and noticed that there was a window open offering an unobstructed view inside of the garage from the outside of this residence. I shined my flashlight inside and observed 3 wire dog kennels and inside two of them I observed what appeared to be 2 dead and decomposing dogs. One of the animals had been decomposed to the point that I was able to see bare ribs. Dep. Dejoie noticed that in another cage there was a dog still alive. Dep. Dejoie made contact with Animal Control. Animal Control Officer Taylor responded to the scene. While Dep. Dejoie and I were waiting on Animal Control

to arrive we could hear more dogs inside of the house barking. Also while waiting on Animal Control to respond I learned that the owners, Kenneth Williams and Lauren Carr, were at a residence in Cantonment and S/Williams had outstanding warrants with this agency for unrelated charges. Dep. Dejoie and I were able to get the deputies in that district to respond. S/Williams was placed under arrest there and transported by Dep. Zabelle #404 to the Escambia County Jail. While at the jail, Dep. Zabelle realized that S/Carr also had an outstanding warrant with this agency so he waited and made contact with her as she arrived at the Escambia County Jail and placed her under arrest.

After Animal Control Officer Taylor arrived on scene she advised that after seeing the two decomposing dogs and the other one inside that these animals, in her professional opinion, were in duress and that we needed to enter the premises in order to save the animals that were still alive. Dep. Dejoie was able to make entry into the open window of the garage. He then opened the garage door. The one young Pitbull puppy that was still alive was taken into custody by Animal Control Officer Taylor. The door leading into the residence was unlocked and Animal Control Officer Taylor along with Dep. Dejoie, Dep. Seely #403, and I entered and found two larger dogs inside of wire kennels. One of the larger dogs had no food or water or bowls to put it in inside of its kennel. The other dog had a container inside its kennel, but had no food or water. Animal Control Officer Taylor and I looked through the rest of the house to ensure that there were no dead or injured animals. In one of the spare bedrooms there was no carpeting or tile and a large quantity of what looked and smelled to be dog feces. In another spare bedroom there was a weight bench with a red couch next to it that contained infant clothing sitting next to this couch. This couch appeared to be covered with dog urine and there were also yellow stains on the carpet that Animal Control Officer Taylor stated appeared to be from dog urine. We then check what is believed to be the master bedroom. This bedroom had a window AC unit going along with a bed and a baby crib.

It should be noted that the rest of the house was not cooled by AC and only had one window open for any fresh air or ventilation.

I was contacted by Dep. Zabelle and he stated that when he made initial contact with S/Williams and S/Carr he asked what their address was and they both stated they lived at 10914 Bridge Creek Dr.

While on the scene, I made contact with neighbor W/Francine Fountain and asked if she new the residents of 10914 Bridge Creek Dr. W/Fontaine stated that she knew what they looked like, but did not know them personally. I then asked W/Fountain how long it had been since she had seen a resident there and she stated that she saw the female (described as a white female, kind of heavy, with red hair) there on 6/22/10 at approximately 10 a.m.

After talking with W/Fountain, I was contacted by W/Jason Koelsch. W/Jason Koelsch stated that he lives next door to S/Williams and S/Carr and he last saw S/Carr on 6/22/10 at approximately 1230 hrs entering and exiting the residence at 10914 Bridge Creek Dr.

I then spoke to W/Jill Koelsch and she stated that she also lives next door to S/Williams and S/Carr and saw S/Carr at 10914 Bridge Creek on 6/21/10 at approximately 1430 hrs.

Crime Scene Tech Wright #709 responded and processed the scene. Dep. Seely and I then went back into the residence, closed and locked the garage door, the interior door leading from the garage to the house, checked to make sure the back door was locked and closed, and locked the front door prior to leaving the scene. I then went down to the Escambia County Jail where S/Williams and S/Carr were being held on unrelated charges and informed them of the new charges and bonds. Both S/Williams and S/Carr were given a Circuit Court date of 7/15/10 and bond of \$10,000 each.
